# Organization of Chinese Americans San Mateo County Announces Scholarship Winners By Alden Soohoo

Dr. Alden Soohoo, Chairman of the OCA Scholarship Committee proudly announces the year 2000 winners of the PHILIP & LOUISE WANG Scholarship, the MONICA & ADRIAN ARIMA Scholarship, the SING FOUNDATION Scholarship, the FABIO FRANCIS & ANNIE SULAIMAN Scholarship, the PACIFIC BELL-OCA SAN MATEO Scholarship, and the WELLS FARGO-OCA SAN MATEO Scholarship. The eleven winners, selected from 128 applicants representing the 22 high schools of San Mateo County, were honored at our Annual Scholarship Awards Ceremony on May 21, at Crystal Springs Uplands School in Hillsborough.

The PHILIP & LOUISE WANG Scholarship consists of five \$1,000 scholarships donated by Philip & Louise Wang, charter members of OCA. The scholarship is awarded based on academic excellence and extracurricular activities. The five scholarship recipients are:

- 1) RICHIE CAI of Jefferson HS will be attending San Jose State University in the Fall. He intends to pursue a career in Computer Science.
- 2) JESSICA CHANG from Hillsdale HS, inspired by personal experience, intends to pursue a career in medicine/neuroscience. Jessica will be attending the University of Rochester in New York.

- 3) ARTHUR KAO from Menlo Atherton HS will be attending Yale University in the Fall.
- 4) DAISY TAM from South San Francisco HS plans to study computer sciences at UC Santa Cruz in the Fall.
- 5) MELANIE WANG is from Hillsdale HS. She will be attending UC Berkeley in the Fall. She will pursue a career in physical therapy.

The MONICA & ADRIAN ARIMA Scholarship consists of two \$500 scholarships donated by OCA San Mateo County members Monica & Adrian Arima. The scholarship is awarded primarily for Outstanding Community Service. The year 2000 recipients are:

- KATHERINE DODGE of Hillsdale HS will be majoring in business and psychology in the Fall at UCLA.
- 2) ANDREW LEE, also hailing from Hillsdale HS, plans to attend UC Berkeley in the Fall where he will study chemistry.

The OCA scholarship fund continues to grow thanks to a generous \$1000 donation from the Sing Foundation. The Sing Foundation honors Sing Kwok, a pioneer in the 1920's in the field of boxcar refrigeration. He was the first successful individual to transport produce from the Salinas Valley to the East Coast in the 1920's. The SING FOUNDATION Scholarship is awarded for community service and financial need.

The first winner of the SING FOUNDATION Scholarship is GEORGE LEE JR. of Aragon HS. George scored a perfect 1600 on the SAT and will graduate at the top of his class. He plans a career in math or as a teacher and will be attending Harvard in the Fall.

Also adding to our scholarship fund this year is the generous \$1000 donation from Fabio Francis & Annie Sulaiman. This scholarship is also based on financial need and academic achievement. Our first winner for THE FABIO FRANCIS & ANNIE SULAIMAN Scholarship is JIAJING YI from Aragon HS. She will be attending UCLA and pursuing a career as a teacher.

The winner of the PACIFIC BELL-OCA SAN MATEO SCHOLARSHIP is JULIE MAA from Capuchino HS. This is a \$1000 scholarship awarded to a student excelling in extracurricular activities. Julie will be attending UCLA in the Fall.

Icebox, Inc. - the parent company of www.icebox.com-currently runs a weekly program on their website entitled "Mr. Wong" which features a stereotypical Chinese American man who serves as a butler for a rich White American socialite named Miss Pam. The portrayal of this Asian Pacific American character is stereotypical in every way. He speaks with an unrealistic accent and has no pride, allowing his boss to step all over him.

#### Dear Mr. Stanford:

It has recently come to the attention of the Organization of Chinese Americans (OCA), a national Asian Pacific American (APAs) civil rights organization, that your animation website - www.icebox.com - proudly features a weekly animation series entitled "Mr. Wong." The series features a Chinese American houseboy who dutifully obeys his Miss Pam, his white American employer- no matter how absurd her requests.

The character of Mr. Wong is a conglomeration of stereotypes – not really a character at all. His buckteeth, slanted eyes, exaggerated accent, slight stature, and submissive personality are all typical of an anti-Asian mindset. The fact that Icebox, Inc. treats racism as comedy is both offensive and baffling.

Fans of the series may argue that the unflattering portrayal of Miss Pam negates the negative depiction of Mr. Wong. White Americans, however, are ubiquitous in American media outlets; Chinese Americans and APAs have very little representation. Miss Pam is clearly not a representation of all white Americans; Mr. Wong, however, is the embodiment of every popular stereotype of people of Asian and Pacific Islander descent. These attempts by Icebox, Inc. to pass off generalizations as entertainment sweeping deplorable. "Mr. Wong" is infused with ignorance from beginning - when Mr. Wong informs the audience that the episode is "rroading" - to end - when the theme song reports how he is less a man than he is a piece of property because he "came with the estate."

"Mr. Wong" is nothing more than a modern-day "Amos 'n Andy" – lacking any trace of either sensitivity or humor. OCA strongly suggests Icebox, Inc. pull "Mr. Wong" from the website immediately.

## **OCA Letter to the Tonight Show**

Dear Producer of the Tonight Show:

The Organization of Chinese Americans (OCA), a national civil rights advocacy organization, is appalled by the Tonight Show's Monday, June 19, 2000 segment making fun of the lax security at the Los Alamos Lab. While Mr. Leno was talking to the actor playing the character of the amateur security chief, an Asian man was shown in the background sneaking out with a computer, and then returning to steal a box of documents marked "Secret."

Your decision to include this kind of mockery is most unfortunate and caused great pain to the Asian American community. At a time in which we are fighting against racial profiling and scapegoating, as well as for equal treatment and justice for Dr. Wen Ho Lee, your insensitivity toward this matter and your deliberate provocation of the matter further serves to promote the myth that Asian Americans are foreign menaces and not to be trusted. On June 20th, President Clinton honored 22 Asian Americans with this nation's coveted Medal of Honor for gallantry during World War II. They fought for our country with outstanding bravery and loyalty. Just when, after 55 years of waiting, Asian Americans were being recognized for what they truly deserved, your program set back the depiction of us once more.

There has been no evidence that Asian Americans have been involved in the disappearance or the reappearance of the Los Alamos hard drives. Your presumption that an Asian was involved was not only misleading, but it also defies logic and reason. Swaying public opinion against an entire group of people serves no purpose but to create greater tension and distrust. The entertainment media should certainly not refrain from satirizing issues such as lax security, but to use an Asian, in particular, is totally unnecessary, and can only promote the stereotype against Asian Americans. There are so many other ways to depict this issue.

More security at the National Laboratories should be a top national priority. Asian American scientists and engineers compose close to 20% of our defense research; they could be earning greater salaries or bonuses outside of the lab, but instead they are working hard and long to improve our defense research and development. They are our nation's other unsung heroes who produce the technology and guard our country so that we can all sleep in peace at night.

I believe you should issue a formal apology to all Asian Americans and especially the hardworking scientists at the defense labs for your witless, offensive show.

# Highlights from the OCA National Board Meeting, April 28-30, 2000

Most of Saturday morning was spent on the Wen Ho Lee case. Alberta Lee, daughter of Wen Ho Lee was invited along with Brian Sun, one of Wen Ho's attorneys, and a public relations person, Stacy Cohen to present their side of the case, in order to give them equal time, because OCA had invited Sec. of Energy Bill Richardson to the January Nat. Bd. Mtg. presentation was emotional and effective in swaying the feelings of most of the attendees to vote for a proposal by Victor Hsi for OCA to join the Coalition Against Racial & Ethnic Scapegoating (CARES), which demands that: 1) Atty. Gen. Janet Reno release Wen Ho Lee from jail on bail; 2) The DOJ initiate an investigation into the circumstances leading to Dr. Lee's indictment and the use of racial profiling against Asian American employees; and 3) Federal Agencies take active measures to eliminate racial profiling and scapegoating against all of our communities. Also, a National Day of Action, on June 8, 2000, is to be organized to mark the six-month anniversary of Dr. Lee's incarceration without bail.

The Board approved the 2001 Convention site to be Seattle. New York, with 4 chapters, New York, Westchester, Long Island, & New Jersey, jointly hosting the event, also made a presentation for the 2001 Convention, but the National Board overwhelmingly chose Seattle over New York.

The Westchester Chapter donated \$2,500 to the National Internship Program, and Carlos Tiu, the Treasurer, personally donated \$3,000, of which \$2,500 will also go to the National Internship Program. The New York Chapter donated \$2,000 to the Endowment Fund. Ariel Lui, the VP for Education and Culture personally raised \$22,000 for a new endowment fund for OCA educational programs.
